Free Guest Passes are Not valid at Parties

Two optional weekends (weather permitting)
September 6th and 7th, September 13th and 14th, 10 AM to 7 PM

- All the information you need — membership categories, application requirements, rules and general information — are included in this publication.
- Membership fees are not refundable. Membership is for the entire season; partial season memberships are not available.
- Smoking is only permitted in the designated area — in front of the mat room.
- Pool members are responsible for apprising their guests of the pool rules.

FEES FOR 2014 POOL SEASON

1. Full Membership

- A. First adult in apartment (age 18 and over)..... \$295.00
- B. Second and subsequent adults in same apartment..... \$225.00 each
- C. Teenagers (age 13 through 17) \$155.00 each
- D. Children (age 3 through 12) \$115.00 each
- E. Babies (under 3) No charge

2. Midweek Membership

- A. First adult in apartment (age 18 and over)..... \$195.00
- B. Second and subsequent adults in same apartment..... \$135.00 each
- C. Teenagers (age 13 through 17) \$ 95.00 each
- D. Children (age 3 through 12) \$ 75.00 each
- E. Babies (under 3) No charge

Shareholders whose maintenance payments are in arrears will not be permitted to have a pool membership. Shareholders will have the cost of guest passes charged to their maintenance account. Renters/Sub-Tenants are responsible for paying guest fees directly to Gerard Owners Corp. as these fees cannot be charged to the apartment owner's maintenance without his/her approval.

GENERAL INFORMATION

Membership Application

Complete the membership application and submit it to the management office together with **two (2) new** color full faced photos of each member and a check made out to Gerard Owners Corp.

Full Membership

A full member may use the facilities seven (7) days a week, may rent chaise lounges, is entitled to ten (10) free guest passes (per apartment), and may purchase additional guest passes.

Midweek Membership

A midweek may use the facilities on non-holiday Mondays through Fridays only and may purchase guest passes only for such days. Midweek members are not entitled to free guest passes and are not entitled to rent a chaise lounge.

Admission to Pool

Members will be issued personal ID cards and will be admitted to the pool only upon presentation of this card to pool staff at the entrance. Guests must be accompanied or signed in by a member and be registered at the pool-entrance. If it rains within one (1) hour of a guest's admittance, the pool manager will issue a rain check. All visitors who are on the pool deck longer than 30 minutes must be signed in.

SAFETY RULES

1. The pool may be used only when a lifeguard is on duty.
2. Swimming is at the individual's own risk and responsibility. Diving is not permitted.
3. Infants, toddlers, and children under the age of twelve must be closely supervised by a **responsible adult at all times.**
4. No sitting is permitted on the pool steps or ladders.
5. Swim accessories, including inflatable toys and floats, are not allowed in the large pool. Water wings and eye goggles are allowed.
6. Ball playing is not permitted in main pool or on pool deck. Unruly behavior, such as horseplay, wrestling, and excessive noisemaking is prohibited.
7. Water guns are not permitted.
8. The black line at the bottom of the pool designates the lane reserved for lap swimmers. Lap swimming is permitted from 10 AM - 12 NOON and from 5 PM - closing. Others may not stand or swim within this designated lane during those hours.

ALL RULES ARE FOR THE SAFETY AND ENJOYMENT OF MEMBERS AND GUESTS. VIOLATORS ARE SUBJECT TO PENALTY OR LOSS OF MEMBERSHIP PRIVILEGES.

Members and guests will not issue orders, interfere with or otherwise abuse the pool management and staff. Any breach of this policy will result in the suspension of pool privileges without return of fees. All complaints will be in writing and directed to the building management office during regular business hours.

ADDITIONAL INFORMATION

1. Pool management has the full authority and responsibility to enforce the pool rules.
2. Paging is provided only for emergency calls.
3. Management reserves the right to close the pool on any day or at any time and to limit the number of people at the pool to its allowed safe capacity.
4. When pool personnel instruct members to leave the pool or pool deck, members must obey their direction. Membership will be revoked if this rule is not adhered to.
5. Rules may be changed, amended, or added at management's discretion.
6. Gerard Owners Corp. is not responsible for loss, damage, or destruction of any property or for any accidents causing personal injuries resulting from the use of the pool or other facilities.

GUEST PASSES

Members may purchase guest passes at the entrance to the pool. These passes may be used in lieu of, or in addition to, the free passes. It is not necessary to use up free passes before purchasing passes. Selling of free guest passes is prohibited. **FREE GUEST PASSES MAY NOT BE USED ON PARTY DAYS. MEMBERS MUST PURCHASE GUEST PASSES FOR PARTY DAYS EVEN IF THEIR FREE PASSES HAVE NOT BEEN EXHAUSTED.**

LOUNGE RESERVATION

Only one (1) lounge may be initially reserved for each apartment having one or more full memberships. A request for the same lounge number used last year must be received at the Management Office by May 1, 2014.

After May 15, requests for a second lounge from an apartment having two or more full memberships will be honored based on availability and date of application.

After May 31, any other lounge requests will be considered based on availability and date of application.

For a second adult living in the same apartment, second lounge will be allowed only with payment of a full membership fee, whether requested prior to or after June 16.

GENERAL RULES

1. Pool members are responsible for their guests' compliance with our rules.
2. Children under the age of twelve (13) must be accompanied by an adult responsible for their safety and conduct and must be closely supervised at all times.
3. FULL LENGTH BEACH TOWELS must be used on lounges. Lounges must be covered completely.
4. Personal injuries must be reported to a lifeguard, pool manager and GT Management.
5. Pool management's orders to remove umbrellas and to vacate the pool area because of inclement weather must be strictly obeyed.
6. Food may be eaten only in the designated area at the far end of the pool or in the party room.
7. Beverages must be contained in cans, plastic, or paper containers only. **Glass bottles or other breakable containers (including hard plastic containers) are not allowed.**
8. Strollers must be braked and kept a safe distance from the pool. Playpens are not allowed.
9. Members with electric wheelchairs must be accompanied by a personal aid in manual mode to their destination and upon leaving must be accompanied to the exit.
10. Radios and cassette players must be used only with headphones.
11. Only chairs, and furniture supplied by the pool management are allowed. No items may be placed to obstruct free passage around the pool.
12. Infants and toddlers must wear swimmies in both pools.
13. No pets are allowed.
14. Only games provided by the pool management are allowed.
14. Personal umbrellas used at pool may not exceed 70" in diameter when fully opened and must not be left unattended while in open position.
15. Smoking is permitted only in the designated area in front of the lifeguard room.
16. All chaise lounges on the deck have been rented and **are for the exclusive use of the renter.**
